Mengapa ada kata “broker”

Kata lain adalah

- Knowledge transfer
- Translational

- **Adanya gap antar peneliti dengan pihak yang menggunakan hasil penelitiannya**
- **Masing-masing mempunyai keyakinan dan perilaku sendiri**

Kata lain: Translational Research

- Translational research merupakan sebuah pemahaman menarik mengenai bagaimana tindakan klinis dipergunakan dari hasil penelitian dasar. Selanjutnya, dari tindakan klinis akan dijadikan bahan kebijakan untuk aplikasi praktis di masyarakat.

Knowledge Brokering

The Job:

- To facilitate the transfer of research and other evidence between researchers and decision makers
- Human force behind knowledge transfer whose task include finding, assessing, and interpreting evidence facilitating interaction, and identifying research questions.

Three different approaches:

- Knowledge Managers
- Focus on the interface between “creators” and “users”.
- Enhance access to knowledge by providing training to knowledge users

Issues:


- Show mixed effects on the rate at which evidence is translated into action;
- Little attention to broad explanations of the process of transferring knowledge into action;
- Do not know much about the process involved in different knowledge transfer intervention.
- Lack of suitable tools for planning and evaluating knowledge transfer activities.

Contoh Gambaran dari paper lain:


